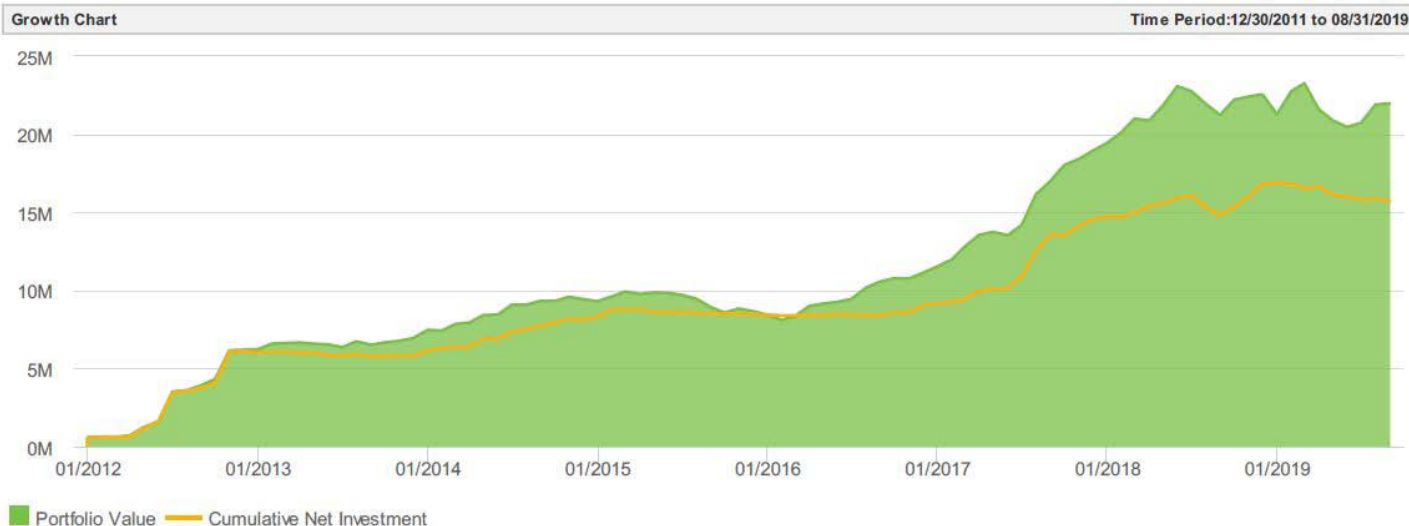

The FX2 Strategy Has Outperformed in Rising Rate Environments

- ❖ Q4 2016, the US 10-Year Treasury Rate rises from a low of around 1.6% to a high of about 2.6%, an increase of roughly 62%, one of the largest percentage increases in interest rates in 50 years
- ❖ Morningstar ranked FX2 the #1 performer in its peer group during this historic period of rate hikes (shaded portion of graph, "Q4 2016 Rate Spike")
- ❖ A portfolio of maturity certain assets is preferred by most in a rising rate environment, and short average maturities help to mitigate interest rate risk
- ❖ FX2 has found S&P 500 like performance in cumulative return since Q2 2016 when interest rates began to rise from their most recent lows

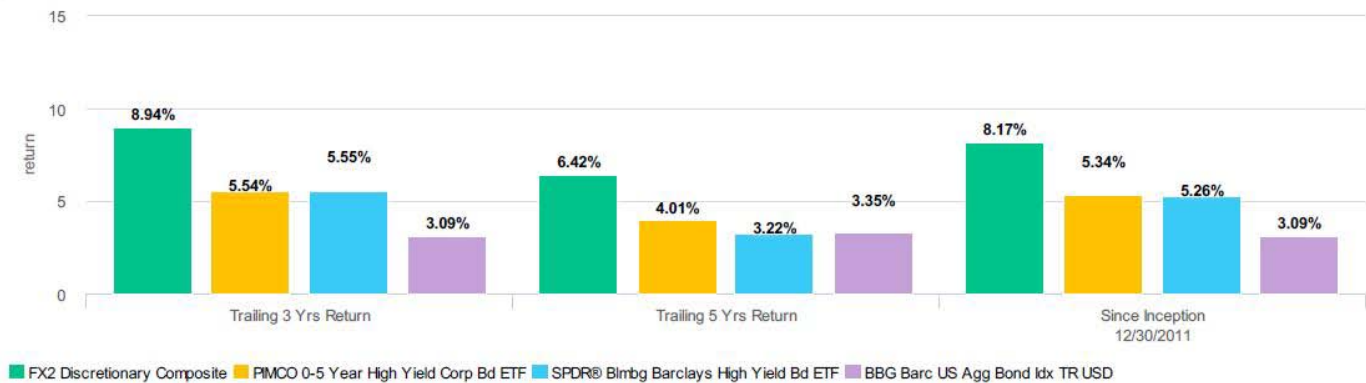

- ❖ The majority of our FX2 accounts are overweight in domestic corporate bond issues that have met our stringent investment criteria
- ❖ We try to maintain average bond maturities in most portfolios at 2-3 years to minimize interest rate volatility and benefit from laddered maturities

Benefits

- ❖ Historically, FX2 has offered investors an outstanding Alpha (active return) of 8.82 (vs. *Benchmark**)
- ❖ A Negative Beta of - 0.88 (vs. *Benchmark**) means FX2 has very minimal correlation to debt markets, while when benchmarked to the S&P 500, FX2 has a low beta of 0.42, meaning it has less volatility than the overall stock market
- ❖ Historically, FX2 has provided an excess return of 5.85% (vs. *Benchmark**)
- ❖ Historically, FX2 has provided Superior Income & Outstanding Performance in Fixed Income
- ❖ Low Annual Management Cost of 0.50% allows for higher net returns to the investor
- ❖ Historically, FX2 has offered exposure to a wide diversity of issuers and industries
- ❖ Low average maturities help to mitigate interest rate risk and keep investments liquid

Bond Portfolio Structure

- ❖ Low average cost + Higher Returns = Higher Net Returns to Clients
- ❖ Discretion allows for active management of investments and enables proactive management
- ❖ Segregated accounts; no pooled funding, so tax implications of the account match that of the investor
- ❖ Investors may access their account online, allowing for 3rd party validation (*TD Ameritrade offers comprehensive, 24/7 account access online to their custodial clients*)
